

REMARKS BY CBSE: - School is required to upload Fire Safety Certificate as per annexure-XII Circular No. 12/2022 dated 14/10/2022 and it must be in the name of school along with validity. The Fire Safety Certificate is to be issued by the Govt. Fire Safety Department/Authorized Officer of the Local Bodies such as Municipal Corporation as prescribed norms with validity (Validity as on date of final submission of application) in the name of school only. Letter/Certificate/ opinion regarding installation or possession of Fire Safety equipment's/extinguisher shall not be treated as a Fire Safety Certificate.

OUR EXPLANATION TO THIS :- The certificate already uploaded by us which is issued in the name of the school by the Fire Safety Department of Govt of Karnataka. As per your remarks we approached the said department, asking for issuing the certificate in your format annexure XII of circular no 12/2022(or Annexure VII). But Fire safety dept of Karnataka Govt is saying, that they are issuing fire safety certificate to everybody (schools or any other organizations) in the said format only as per government rules, they cannot issue in any other format.

So, we request you to kindly accept our already uploaded fire safety certificate.
