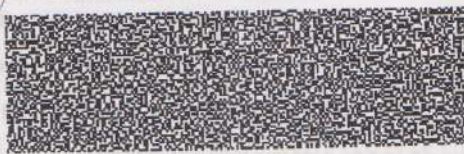

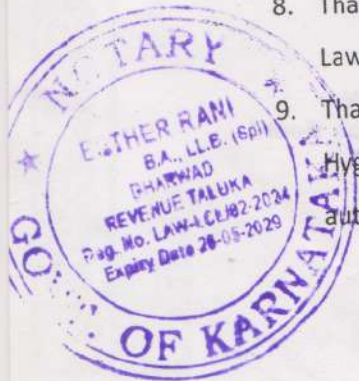

AFFIDAVIT

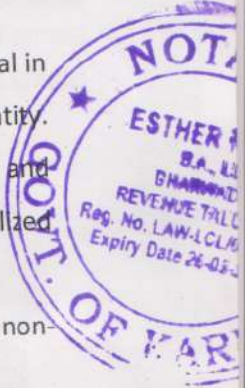
I/We Shrikant Patil Son of / Daughter of /Wife of , Trimbakarao Patil age 72 (years),

The school undertakes to abide by the provisions contained in the affiliation and examination byelaws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.


